Pricing


the cost of one dive ticket is 2300 € and includes the following benefits:

Responsibility

Indemnity


You are responsible for and must indemnify the location owners for any loss or damage to the location arising out of your use, or any substituting person attending the event location.

 - ✔ Confirms the third party will be liable to the location owners (in addition to the agent) for payment of the Event Charge (including any cancellation fees) notwithstanding that they have not personally signed these terms and conditions.
